**The Figures Speak**—Some of the members of our Finance Committee have the feeling that some of our people have not understood our Building Fund report on the front of **The Builder**. Just to be sure we are going to leave off the "Balance" from the report until we can also show the figure for "Balance Due." It must be kept in mind that at the present time **we owe more than we have given and borrowed**. I wish that I could give you the exact figure. This will not be possible until all of the bills have been received. Beginning with this month we are due to make repayment of \$4500 each month on the bank loan. That all adds up to the fact that faithful stewardship is imperative.

**Horrible Mistake**—Kenneth Everett, Tulsa Baptist pastor, faces the problem of a tavern being opened across the street from the church. He and other Baptists in the Oklahoma city protested issuance of a permit to the tavern. The county judge told them, "It looks like you'll have to open a dance hall nearby to avoid the issuance of a beer license to a tavern across the street from the church." The judge, while declaring himself sympathetic to the Baptists, said state law forbids taverns near dance halls but contains no restrictions on taverns near schools and churches. Church and school leaders prepared afterward to take their case before the state legislature.—Baptist Press.

**Revival Services** are scheduled for February 17-24. The pastor will preach, using I John as the basis for the messages. Gene Brasher, Minister of Music at East Hill, will direct the music for the week time services.
