

Faith Healers—Many people have failed to distinguish between the power of God to heal and the "professional" faith healer. Not long ago a suit against a faith healer was instituted in the courts by a mother who claimed that her child had not been healed. At last report it is my understanding that the so-called healer was ill with polio himself.

Pastor John H. Scalf, of the Jamestown Baptist Church, in North Carolina wrote, December 8, of his personal visit to services conducted by Oral Roberts in the High Point-Thomasville area. He states in part:

"During these services I believe that we saw most of those who were supposed to be healed. On my desk as I write this letter I have the names of 12 of the outstanding cases who were supposed to have been healed. Mrs. Scalf and I met these people, talked with them and visited with some of them in their homes weeks later.

The result of our investigation was that not one person was found to be healed. One woman who professed to be healed of an inward goiter misrepresented her condition and feigned healing, evidently to get



attention. We went to see her doctor who happened to be a leading Baptist layman in High Point and he very emphatically stated that he had been her doctor for a long time, had operated upon her two or three times and that she never had a symptom of a goiter.

Another woman who lives south of High Point was supposed to have experienced the most outstanding miracle of healing. The goiter did disappear when she was prayed for. We thought that this might be the real thing until we talked with her and saw a swelling low in the throat. We made a trip to the Baptist hospital in Winston-Salem and talked to two doctors who were specialists and they informed us that one type of goiter can be pushed around under the skin and can be made to partly disappear in the throat. We saw this woman later and she still had the goiter.

I believe in God's power to heal our bodies if He so desires. I believe that He does heal some instantly when He sees that it will be for His glory. Then, too, I believe that He uses means for healing which He has put in this world for that purpose."

This is the testimony of Mr. Scalf.
