





ANNUAL REPORT OF THE CHURCH CORPORATION

All members of the church congregation are also automatically members of the church corporation, First Baptist Church of Pensacola, Inc., chartered as a nonprofit corporation under the laws of Florida. Until recently, the function of the corporation has been limited to holding legal title to all of the church real estate and executing all contracts, mortgages, deeds and other legal instruments relating to real estate. Under revised bylaws adopted in 1982 the corporation was also assigned the responsibility of administering and investing funds contributed to the church by special gift or bequest and other reserve funds. To oversee the investment of all of these funds, and to encourage additional gifts and bequests, the bylaws directed that a Foundation Committee be established. 1983 was the first full year in which the corporation and its Foundation Committee have had these additional responsibilities.

We are pleased to submit this report identifying the funds under administration with their principal and interest balances at December 31, 1983. The first eight of the funds listed below were created in earlier years and transferred to the corporation for management in 1983. The other funds resulted from gifts and bequests received in 1983. The funds are grouped in accordance with the purposes for which they were given.

MISSION FUNDS

1. Income distributed annually $\frac{3}{5}$ to Lottie Moon Offering, $\frac{1}{3}$ to Annie Armstrong Offering. Donated by an anonymous couple. Principal \$60,000.00; interest \$6,825.15 (interest since distributed for the designated purposes).
2. Income distributable annually $\frac{1}{4}$ to home missions, $\frac{1}{4}$ for state missions, $\frac{1}{2}$ for foreign missions. Donated by Mrs. Claudia C. McCurley, Principal \$1,419.78; income \$163.80 (interest since distributed for designated purposes).

FUNDS FOR YOUNG PEOPLE OR THEIR ACTIVITIES

3. Interest to be used to assist girls in attending camp. Donated by Harvey Hedrick Missionary Group. Recipients to be selected by the Mission Action Chairman of WMU in consultation with church staff. Principal \$1,032.25; income \$109.20.
4. Income to be used to assist young people in attending Foreign Mission Week at Ridgecrest. Income not so used in any year may be added to Lottie Moon Offering. Donated by Miss Annie (Nan) Beggs in memory of her father Judge E.D. Beggs (1861-1940). Principal \$5,000.00; interest \$456.25.
5. The Dolly McGowin Memorial Fund donated by her mother, Mrs. E.F. Dunbar, the income to be used to foster youth work in the church. Principal \$5,500.00; income \$1,862.33.
6. College Scholarship Fund consisting of the gift of \$10,000.00 from Mr. and Mrs. Sandy Sansing and a gift in memory of Dr. H.T. Dukes of \$940.00. Income is to be used for scholarships for students attending Pensacola Junior College, University of West Florida, or other educational institutions, in that order of priority in the allocation of funds. A Scholarship Fund Committee has been established by the church to make scholarship awards from available income. Principal \$10,940.00; income \$1,289.44.

FUNDS FOR CONSTRUCTION OF A NEW CHAPEL

7. Gift from the estate of our beloved Earl R. Gaston to be used to assist in the construction of a chapel. Principal \$21,942.24; income \$666.13.
8. Bequest under will of Mrs. Hazel Watson Coleman to be used in establishing or assisting a church or mission in an inadequately churched area or, if impracticable, then in constructing or furnishing a new chapel. The fund remains intact. Principal \$6,446.20; interest \$627.01.

GENERAL RESERVE FUND

9. This fund originated with a generous cash bequest of \$22,959.99 under the will of Mrs. Jan P. Ainslee received in December, 1983. Additional bequests and special gifts to the church for which no use or purpose is specified (other than undesignated gifts to the Memorial Fund) will be added to this fund, including proceeds from sales of real estate, stocks, bonds and other assets donated or willed to the church for which no purpose or use is specified by the donor. All such funds will be kept invested and the income accumulated until the specific use of income or principal is authorized by the church corporation. Principal \$22,959.99. First interest will be credited in 1984.

MEMORIAL GIFT PROGRAM

The Foundation Committee inaugurated in the last half of 1983 a plan to receive gifts made to the church in memory of deceased persons and also to honor living persons. A very attractive "Book of Remembrance" is on special order and should shortly be placed in the church vestibule under glass. The name of each person honored by a gift to this fund, whether living or deceased, will be recorded in this "Book of Remembrance." The names of the donors will be published in "*The First Baptist Builder*" and kept on record in the church office. Attractive acknowledgement cards are sent to each donor and an announcement of the gift is sent to the bereaved family or to the honored living person.

Gifts may be for designated purposes such as the Endowment Fund (No. 10 below), the library, the building fund, Lottie Moon Offering, or as additions to any of the nine funds listed above. Undesignated memorial gifts will be placed in the Endowment Fund for permanent investment. The early response to this Memorial Gift program has been gratifying. Gifts received in the less than six months that the Fund has been operated have been as follows:

10. Endowment Fund. Memorial gifts designated for this Fund under the program described above, as well as all undesignated memorial gifts, will be accumulated in this fund and permanently invested. The principal will be held inviolate. The income, upon approving vote of the congregation specifying an unanticipated emergency need other than budgeted items, current expenses, previously incurred obligations and the like, may be applied to such need. Unexpended income will be accumulated. Principal \$1,182.92

SPECIAL PURPOSE TEMPORARY FUNDS

11. Proceeds of \$9,905.00 from sale of parcel of real estate given to the corporation by James D. Cronley, a non-Baptist who has benefited from attending our weekly Businessmen's luncheons. As directed by the donor, this Fund is being applied to air conditioning the new school bus acquired in 1983 and the balance remaining to the cost of the annual Challenger Award Banquet.

12. A generous gift of \$50,000.00 from an anonymous donor in December, 1983, for the purpose of buying three special type vans to meet the needs of the elderly and handicapped and to provide transportation to retreats and for other special programs of the church. This gift has been invested pending delivery of the vans, which have been ordered.

13. Contributions from several members of the Board of Directors and of the Foundation Committee to cover the cost of the handsome but expensive "Book of Remembrance", other printing expense and general "start-up" expenses. Balance on hand \$2,096.38.

REAL ESTATE HELD IN TRUST

Three parcels of real estate not presently being used for any church purpose were approved for sale by members of the corporation at the annual meeting on January 29, 1984, as follows:

- Former homeplace of Mrs. Georgia Booker Parker in East Pensacola Heights offered at \$27,500.00 cash. If sold, the proceeds will be added to the General Reserve Fund.
- Small parcel of real estate included in the bequest from Mrs. Jan P. Ainslee in addition to the cash already received. This is an irregular fractional lot on 9 Mile Road with an estimated value of \$5,000.00. If sold, its proceeds will also be added to the General Endowment Fund.
- Approximately 4.1 acres on University Parkway, near the University of West Florida, acquired in about 1968, at a cost of \$28,000.00 (less gifts of several thousand dollars subsequently made to the church by the seller), and presently appraised at \$72,500.00. It is thought that a consensus should be sought from the Mission Committee of the Church, the Board of Directors of the corporation and the Board of Deacons for a recommendation to the church membership on how the proceeds from this sale should be used or invested, the proceeds to be temporarily invested pending such action.

A WORD OF APPRECIATION

The Board of Directors of the corporation and the members of the Foundation Committee greatly appreciate the gifts and bequests detailed in this report, and the wonderful acceptance of the church membership of the Memorial Gift program and the permanent Endowment Fund. We encourage all church members who are in a position to do so to do so order their financial affairs that in their lifetimes by gifts and at their deaths by bequests they will, out of their material blessings, demonstrate their love for our Heavenly Father and their desire to promote the establishment of His Kingdom. Additions may be made to any of these established funds or for other designated purposes.
